**Duration:** October 2, 2023 (or sooner if available) – December 1, 2023

**Deadline to apply:** applications must be received by 5pm on September 1, 2023.

**Pay:** This is an unpaid position; however, interns will receive a total stipend of \$1500. This stipend will be limited to expenses related to internship duties.

**Qualifications:** Open to active undergraduate or graduate students working toward a degree with course work in natural sciences, environmental education, natural resource management, water quality, or a related discipline.

**Expected training and experience:** Student interns with BSWCD will assist Education and Outreach staff in the coordination, organization, and teaching of Salmon Watch, our annual environmental education program. Training and experience may include:

- Guiding students, chaperones, and teachers through interactive Learning Stations in the field
- Meeting professionals and exploring potential career opportunities in natural resources and environmental education
- Volunteer coordination, communication, training, and mentorship
- Creation of outreach materials
- Maintenance of program equipment and materials


All internship training and experiences are for the benefit of the intern and will be coordinated with the intern's academic studies. Interns will receive ongoing instruction and training from BSWCD and shall work under their close supervision. Interns are not entitled to wages or other compensation for the time spent in training, though a stipend for expenses such as books and tools may be provided. Interns will not displace any regular employees of BSWCD, and internship does not entitle an intern to a job at the conclusion of the training period.

The intern will meet regularly with BSWCD staff to review progress and training. BSWCD staff and the intern will meet periodically with the intern's faculty advisor to review training, work experience, and fulfillment of internship objectives.


